We currently operate three educational programs. We administer Cooking Classes for Better Health, during the Park City School District after school programs, where students gain lifelong, tangible skills and inspiration through experiential learning. Adventure Bites is a program in partnership with Park City School District (PCSD), with the goal of expanding student's palates. Adventure Bites takes place in all PCSD Schools reaching 5,000 students over multiple lunch hours. Each of the seven PCSD schools have an indoor tower garden, with four hosting outdoor gardens, where students can literally see food go from seed to plate. Teachers and EATS staff alike use these spaces to teach a plethora of academic subjects (math, science, engineering), life skills, and a
